1. Aims

Relationships and Sex Education (RSE) is part of a school curriculum that is required to promote spiritual, moral, cultural, mental and physical development of pupils and prepare them for the opportunities, responsibilities and experiences of adult life.

The aim of RSE will be to provide balanced and factual information about human reproduction, together with a consideration of the broader emotional and ethical dimensions of sexual attitudes.

The RSE programme will be set within a framework of values that seeks to promote and support the best standards of family life, whilst taking into account the age and understanding of the pupils.

The general purpose of the programme will be to:

- Provide a framework in which sensitive discussions can take place
- Prepare pupils for puberty, and give them an understanding of sexual development and the importance of health and hygiene
- Help pupils develop feelings of self-respect, confidence and empathy
- Create a positive culture around issues of sexuality and relationships
- Teach pupils the correct vocabulary to describe themselves and their bodies

2. Statutory requirements

As a secondary academy school we must provide RSE to all pupils as per section 34 of the <u>Children and Social work act 2017.</u>

In teaching RSE, we are required by our funding agreements to have regard to <u>guidance</u> issued by the secretary of state as outlined in section 403 of the <u>Education Act 1996</u>.

At Langley Park School for Boys we teach RSE as set out in this policy.

In drawing up a policy schools are expected to take steps to ensure that any RSE is given in a manner which encourages pupils to have due regard to moral considerations and the value of family life.

Parents may withdraw their child from all or part of RSE - except that which is included in the National Curriculum, see section 8 for more details.

The Role of the Parents

The prime responsibility for bringing up children rests with parents. Therefore, teaching on RSE will aim to be complementary to and supportive of their role.

In the event of parents wishing to withdraw their sons from RSE lessons they should write to the Headteacher, who would then invite parents to discuss their concerns with them. Parents do not have to give a reason for their decision to withdraw their son from RSE, however a confidential discussion with the Headteacher may well be helpful so that any misunderstandings about the nature of RSE provided by the school can be resolved.

On joining the school, parents are advised of the procedures for working and consulting with staff in the publication 'Notes for Parents'.

3. Policy development

This policy has been developed in consultation with staff, pupils and parents. The consultation and policy development process involved the following steps:

- 1. Review a member of staff or working group pulled together all relevant information including relevant national and local guidance
- 2. Staff consultation all school staff were given the opportunity to look at the policy and make recommendations
- 3. Parent/stakeholder consultation the policy document was shared with parents and other interested parties and comments / concerns were welcomed.
- 4. Pupil consultation we investigated what exactly pupils want from their RSE through focus groups.
- 5. Ratification once amendments were made, the policy was shared with governors and ratified

4. Definition

RSE is about the emotional, social and cultural development of pupils, and involves learning about relationships, sexual health, sexuality, healthy lifestyles, diversity and personal identity.

RSE involves a combination of sharing information, and exploring issues and values.

RSE is not about the promotion of sexual activity.

RSE focuses on giving young people the information they need to help them develop healthy, nurturing relationships of all kinds including:

Families

Respectful relationships, including friendships

Online and media

Being safe

Intimate and sexual relationships, including sexual health

These areas of learning are taught within the context of family life taking care to ensure that there is no stigmatisation of children based on their home circumstances (families can include single parent families, LGBT parents, families headed by grandparents, adoptive parents, foster parents/carers amongst other structures) along with reflecting sensitively that some children may have a different structure of support around them (for example: looked after children or young carers).

5. Curriculum

Our curriculum is set out as per Appendix 1 but we may need to adapt it as and when necessary.

The school's resources for teaching RSE are high quality, evidence based and age- appropriate. All resources are regularly checked by the PSHE Lead to ensure that;

- they align with the teaching requirements set out in the current statutory RSE guidance.
- they are evidence-based, up to date, and give pupils factual knowledge around sex, sexual health and sexuality within the context of relationships.
- they are appropriate given the age, developmental stage and background of our pupils.
- they are sensitive to pupils' understanding and experiences and won't provoke undue stress.
- they support pupils in acquiring the skills and confidence to make considered decisions about safe and lawful sexual behaviour and personal safety, now and in the future.
- they signpost students to access further support if necessary.

Outside resources are always taken from credible sources such as, PSHE Association, Unifrog and Oak National. Classroom teachers provide feedback on the effectiveness of resources to the PSHE Lead to be adapted if required. Resources are further quality assured through learning walks and student feedback in 'student voice' sessions

We have developed the curriculum in consultation with parents, pupils and staff, taking into account the age, needs and feelings of pupils. If pupils ask questions outside the scope of this policy, teachers will respond in an appropriate manner so they are fully informed and don't seek answers online.

6. Delivery of RSE

RSE is taught within the personal, social, health, citizenship and economic (PSHCE) education curriculum. Biological aspects of RSE are taught within the science curriculum, and other aspects are included in religious education (RE).

Pupils also receive stand-alone RSE sessions delivered by a trained health professional.

Responsibility for co-ordinating and reviewing the RSE policy of the school will rest with the pastoral Assistant Headteacher. The policy will be reviewed annually. Planning and delivery of the policy will be shared between the pastoral Assistant Headteacher, the Head of Science and the Head of Religious Studies, together with those staff specifically allocated related responsibilities.

RSE will be taught within National Curriculum Science education and as a discrete topic within the broad programme of PSHCE; the Religious Studies curriculum will also deal with related topics. Science staff will teach all the aspects in the National Curriculum course. All form tutors (years 7-13) will have some input through the teaching of PSHCE.

The overall approach to teaching about sexual matters will be to present facts in an objective, balanced and sensitive manner, and at the same time generate a classroom atmosphere within which pupils can ask questions and discuss sexual matters without embarrassment, guilt or anxiety. Within RSE lessons

the methodology applied will vary from teacher-led instruction to pupil-led small group discussion. It is standard practice in PSHCE lessons for pupils to take an active part in the learning process by leading discussions and challenging each other's ideas.

Various resources are used to support the teaching of RSE, including visits from qualified health professionals and the use of carefully selected videos. The images used in videos relating to human reproduction and contraception are almost entirely in diagrammatic form and occasionally contain a degree of explicit material [eg how to correctly put on a condom]. This method of presentation frequently enables sensitive issues to be approached with accuracy and clarity.

When using external providers we make appropriate checks to make sure that their approach to teaching RSE is balanced, that their resources are age appropriate, evidence-based, and in line with current RSE statutory guidance. External agencies are vetted in advance of school visits to ensure they are meeting curriculum goals and that they have appropriate credentials to deliver high quality RSE. Previsit meetings with the external providers are used to clarify expectations and discuss session content.

External agencies are required to provide their materials in advance, these are checked by the PSHE Lead to ensure that they meet the intended outcome of the relevant parts of the curriculum and are in line with current RSE statutory guidance. These materials are also available for parents/carers to review if requested.

Our usual safeguarding procedures are followed when using external agencies. Teachers are always in the room during sessions with external speakers. Resources are further quality assured through staff feedback and 'student voice' sessions.

7. Assessment

Assessment in RSE is designed to support pupils' personal development, understanding and progression in key life skills. Whilst RSE is not subject to formal examinations, we recognise the importance in monitoring learning to ensure high-quality RSE provision.

We use a range of assessment strategies including:

- Observation of student discussion. Teachers regularly assess the quality of pupil contributions in class discussions, paired discussions and group work.
- Ipsative Assessment. Pupils' progress in RSE is measured against their own previous learning and development. This is often measured against baseline assessments at the beginning of a lesson or unit of lessons. This approach supports personal growth and recognises individual pupils have different starting points in their knowledge and understanding.
- Self-assessment. Pupils reflect on their own learning and provide feedback, either written in PSHE books or through discussion.
- Written and creative tasks. Pupils may complete reflective responses to show understanding of key topics.
- End of unit quizzes. Short quizzes and feedback forms are used after each unit to consolidate learning and check pupil understanding.
- Student Voice. Pupils provide feedback on RSE to ensure it is relevant, engaging and effective.

8. Roles and responsibilities

8.1 The governing board

The governing board will approve the RSE policy, and hold the Headteacher to account for its implementation.

8.2 The Headteacher

The Headteacher is responsible for ensuring that RSE is taught consistently across the school, and for managing requests to withdraw pupils from [non-statutory/non-science] components of RSE (see section 8).

8.3 Staff

Staff are responsible for:

Delivering RSE in a sensitive way

Modelling positive attitudes to RSE

Responding to the needs of individual pupils

Responding appropriately to pupils whose parents wish them to be withdrawn from the [non-statutory/non-science] components of RSE

Staff do not have the right to opt out of teaching RSE. Staff who have concerns about teaching RSE are encouraged to discuss this with the Headteacher.

All form tutors (years 7-13) are expected to deliver components of the RSE curriculum during PSHCE lessons in form periods.

All science staff are expected to deliver RSE lessons as part of the national curriculum in key stages 3 and 4.

8.4 Pupils

Pupils are expected to engage fully in RSE and, when discussing issues related to RSE, treat others with respect and sensitivity.

9. Parents' right to withdraw

Parents have the right to withdraw their children from the [non-statutory/non-science] components of sex education within RSE up to and until 3 terms before the child turns 16. After this point, if the child wishes to receive sex education rather than being withdrawn, the school will arrange this.

Requests for withdrawal should be put in writing using the form found in Appendix 2 of this policy and addressed to the Headteacher.

A copy of withdrawal requests will be placed in the pupil's educational record. The Headteacher will discuss the request with parents and take appropriate action.

Alternative work will be given to pupils who are withdrawn from sex education.

10. Training

Staff are trained on the delivery of RSE as part of our continuing professional development programme.

The Headteacher will also invite visitors from outside the school, such as school nurses or sexual health professionals, to provide support and training to staff teaching RSE.

11. Monitoring arrangements

The delivery of RSE is monitored by Mr B A Jones [pastoral Assistant Headteacher] through:

- > Learning walks
- > Pupil Questionnaires

This policy will be reviewed by Mr B A Jones [Pastoral Assistant Headteacher] annually. At every review, the policy will be approved by Ms S Munday [the Headteacher].
